



The Olde Village Market is an open air market where local vendors are available to sell fresh farm produce, organic and non-organic, fresh flowers and plants, processed farm goods, cheese, baked goods, and high quality handmade crafts as well as trash to treasure sale area. Local musicians and prepared food available. The Olde Village Market is managed by the Honeoye Lake Area Chamber of Commerce Market Committee. Before completing this application for market membership and booth space, prospective vendor's should carefully review and complete the vendor application. It is the vendor's responsibility to meet any and all Health Department regulations and to obtain any required licenses necessary to operate in Ontario County.

Market Location, Dates and Hours

The Olde Village Market will be located on Main Street in Honeoye. The market will be held every Saturday, June through August. 7am - 12 noon. Vendors are strongly encouraged to remain at the market until 12 noon. The market will take place rain or shine.

Fees

Individuals and businesses selling products at the Olde Village Market are generally referred to as vendors and/or producers. They will also be considered "Market Members"- a term intended to suggest their specific relationship and commitment to Olde Village Market, as well as Olde Village Market 's to them. In 2011, members that complete an application and submit payment for all 13 dates and are accepted by the committee will receive an assigned space according to the limitations of the market and notified of their space assignment by the Thursday before the market date. In order to be considered for a single date, the application and payment must be received by the Market Committee by the Wednesday before the market date they desire. The committee will accept walk-ups on any market Saturday. All vendor spaces will be assigned by the Olde' Village Market Committee and all decisions are final. All 501C3 organizations will not be charged for non -food or non-resale product booths.

#### Application Acceptance and Space Reservation

The number of spaces will be determined by the Olde' Village Market Committee, as will the allocation of specific spaces to specific vendors. The committee will attempt to keep a balance between farm products and other goods and crafts that are available. The Market Committee will use an 80-20 guide for home grown produce. Local and home grown farm products will need to be 80% of your "table" with 20% wholesale or purchased outside. However, the preference and the intent of the committee is to have the largest amount of vendors selling locally grown farm produce each Saturday. We will do our best to be fair to all our vendors and our community purchasers for healthy, home grown products.

The number of years a vendor has participated will be considered in the assignment of spaces.

Applications will be reviewed and accepted or rejected on a rolling basis. That is, Olde' Village Market Committee will evaluate applications in the order they are received until all market spaces have been filled. Anyone submitting an application after all such spaces have been filled will be placed on a waiting list and will be notified in the order applications were received; list will be made available upon request to any prospective vendor.

We will be practicing "green" as much as possible and keep the overhead and costs as low as possible as well as market committee volunteers. All participants will practice our CARRY IN-CARRY OUT policy, No refuse will be left on site. All sites will be clean and under no circumstances will products, supplies or tents left on site at the end of the each Saturday.

Olde' Village Market members/vendors agree by signing this application form to accept the following hold harmless clause:

All authorized vendors participating in the Olde' Village Market agree that they are independent operators and not partners or joint ventures and shall be individually and severally liable for any loss, personal injury, deaths and or any other damages that may occur as a result of the vendor's negligence or that of its employees, agents or associations. All vendors agree to indemnify and save the Honeoye Lake Area Chamber of Commerce, Olde' Village Market Committee and Stone Construction Inc. harmless from any loss, costs, damages and other expenses including attorney's fees, suffered or incurred by the Olde' Village Market Committee, Honeoye Lake Area Chamber of Commerce and Stone Construction Inc. by reason of the vendor's negligence or intentional misconduct or that of its employees, agents and associates; provided that, the vendor shall not be liable for nor required to indemnify the Olde' Village Market for the negligence of any of them or that of their servants, agents, employees or associates. It is recommended that each vendor carry his or her own personal and product liability insurance. Furthermore, vehicle liability insurance is required to cover any damage caused.
